in the year **2008** breeding season.

1. The stud fee shall be \$1000.00 (Multiple mare discount for 2 mares or more is 20% off). The remaining balance must be received as soon as mare is checked in foal between 15 to 20 day pregnancy exam. After 1 month from 20 day check, a late fee will be charged at \$20.00 per month until paid in full.

2. The Arabian stallion will be standing at NORTHWIND ARABIANS and the mare care fee is \$5.00/ per day dry and \$7.00/ per day wet. The Mare will be left until settled or returned as many times as necessary during the season between the dates of March 1, 2008 and August 15, 2008.

3. I represent and warrant that the Mare to be bred is halter broken, in sound breeding condition, healthy, and free from infectious, contagious or transmissible disease. A current negative Coggins Test, photocopy of both sides of the registration paper, veterinarian's health certificate should also accompany the

return of this contract. NWA. Reserves the right to refuse Mare if not in proper condition. Mare Owner will pay all veterinarian, and farrier expenses.

4. I agree that Northwind Arabians, the Breeder, and any person associated with Northwind Arabians is not liable for death, sickness and/or accident including consequential damages caused to the Mare and/or foal; and that I am not liable for death sickness, accident and/or other harm including consequential damages caused to the Stallion, and/or property, or persons associated with Northwind Arabians.

5. The Mare Owner agrees to allow the Farm Veterinarian to check the mare for normal breeding conditions and to perform any services necessary to maintain general and reproductive health of the mare at the expense of the Owner. The Owner is requested to furnish the Farm with complete immunization and worming records, also any past breeding history that proves beneficial. All vaccinations, 4-Way (Tetanus, Sleeping Sickness and Influenza), Rhinopneumonitis (Ft. Dodge killed strain, Pheumabort-K+1) along with Strangles Bacterin can be given at the Farm at the request of the Owner. All in bound mare will receive all of the vaccinations upon arrival to the Farm unless the Owner presents a signed Veterinary Health Certificate stating the mare has received her vaccinations.

6. This contract shall not be assigned or transferred without the written consent of NORTHWIND ARABIANS.

7. The Breeder agrees to diligently try to settle the above named mare and shall have sole discretion of determining the best method of breeding such mare. If, however, the mare does not settle, Mare can be substituted with Northwind Arabians permission or the Breeder shall be held harmless.

8. The Breeder requires 48 hours advance notice when the Mare Owner wishes to remove his mare(s) from the farm. The mare (and foal, if applicable) shall be released only upon payment in full of all outstanding invoices, including those from the attending veterinarian.

9. The mare owner is responsible for all veterinarian charges related to the pregnancy of the mare. The mare owner agrees to have said mare examined for pregnancy per the following minimum dates, and to notify NORTHWIND ARABIANS of the results.

A. Between 17 and 20 days following the last breeding, by ultrasound, and if positive, then:

B. Between 45 and 60 days following the last date of breeding.

10. The mare owner understands that both the mare and the resulting foal must be DNA by the Arabian Horse Registry of America, Inc., prior to the registering of

the foal, and any foal conceived in any manner not complying with this contract will not be eligible for registration.

11. The breeding season in force for this contract shall begin March 1 and close August 15 of the year dated on this contract.

12. A breeder's certificate will be issued to Mare Owner after all expenses have been paid in full and upon notification of birth of the foal.

13. If the mare bred to the stallion fails to produce a live foal—defined as one that survives for 72 hours, as certified in writing by a licensed veterinarian, within one week of such determination and provided in writing to NORTHWIND ARABIANS within 30 days of the death of such foal—NORTHWIND ARABIANS will provide a rebreeding. Rebreeding must occur in the next succeeding breeding season or the rebreeding right shall be lost. There will be a \$100.00 rebreeding fee.

14. **CONDITIONS FOR ACCEPTANCE FOR MARES TO BE BRED.** Prior to the Breeding Northwind Arabians or its custodian shall be furnished with a copy of the Mare's Registration Papers and it is recommended that the mare have a SCID test done. (Heritage Banker is in the process of being tested)

15. Should the stallion become unavailable for breeding due to medical reasons including illness, infertility or death, prior to any breeding, the Client shall receive a 100% refund of the Stud Fee. Once the mare has started breeding the refund will be reduced by 5% for each time bred, bred once refund of 95%, bred twice 90%, bred 3 times refund of 85%, and 4 or more times bred 80%, of the Stud Fee, will be given to the Client. In the event of death, illness or infertility of the mare, an approved mare may be substituted at no additional charge. In the event that the mare or substitute mare does not settle in two seasons, the Live Foal Guarantee shall be voided.

16. This agreement shall be a binding contract when signed and accepted by both parties. This agreement shall be governed / by the laws of the State of Wisconsin, and venue shall be in Rock County, Wisconsin. In the event counsel is retained to enforce the provisions of this agreement, the prevailing party shall be entitled to collect all reasonable attorney's fees and costs.

I / WE, THE UNDERSIGNED, CERTIFY THAT I / WE ARE THE MARE OWNER NAMED HEREIN OR A DULY AUTHORIZED AGENT THEREOF, AND AS SUCH HAVE THE AUTHORITY TO ENTER INTO THIS CONTRACT, AS WITNESSED BY MY / OUR SIGNATURE. I / WE ALSO CERTIFY THAT I / WE HAVE READ AND UNDERSTAND THE TERMS OF THIS CONTRACT AND FEE SCHEDULE.
